

APPLICATION OF MID-ATLANTIC INTERSTATE TRANSMISSION, LLC FILED PURSUANT TO 52 PA. CODE CHAPTER 57, SUBCHAPTER G, FOR APPROVAL OF THE SITING AND CONSTRUCTION OF THE HUNTERSTOWN-ORRTANNA 115 KV TRANSMISSION LINE PROJECT LOCATED IN HIGHLAND, FRANKLIN, BUTLER, CUMBERLAND AND STRABAN TOWNSHIPS IN ADAMS COUNTY, PENNSYLVANIA

To whom it may concern:

Enclosed for your information, is the Notice of Filing of Mid-Atlantic Interstate Transmission LLC ("MAIT"), a FirstEnergy ("FE") company, regarding MAIT's Application to site and construct the Hunterstown-Orrtanna 115 kV Transmission Line Project ("Project"), which was filed with the Pennsylvania Public Utility Commission ("Commission") on April 13, 2021. MAIT also has been issued a certificate of public convenience as a Pennsylvania public utility pursuant to the Commission's Opinion and Order entered August 24, 2016 at Docket Nos. A-2015-2488903 et al. Accordingly, the Commission asserts jurisdiction over the siting and construction of transmission lines by MAIT in Pennsylvania pursuant to the Commission's regulations at 52 Pa. Code § 57.71, et seq. The Application has been developed in the format described in 52 Pa. Code §57.72.

As explained in the Notice of Filing and Application, FirstEnergy has identified the need to construct a new 115 kV transmission line circuit originating at from an existing 3-terminal switch location on the existing Hunterstown-Orrtanna-Lincoln 115 kV Transmission Line to Orrtanna Substation in Adams County, Pennsylvania. The proposed transmission line is needed to provide redundancy in the area and to ensure reliable long-term services to customers in the surrounding territory. The entire length of the proposed route is approximately 9.1 miles and will utilize 100-feet of an existing generally 200-foot-wide right-of-way. The Project will be constructed to double circuit to accommodate the new circuit and the existing circuit. Upon completion, the existing wood pole line will be removed. The route traverses through Highland, Franklin, Butler, Cumberland and Straban Townships, in Adams County, Pennsylvania. The Notice of Filing attached hereto also includes a map which shows the general location of the Project.
