Dear Secretary Chiavetta:

On June 5, 2014, the Pennsylvania Public Utility Commission (“Commission”) adopted and entered an Order (“June 5 Order”) at the above-captioned dockets, which addressed the compliance portion of a March 19, 2014 filing by Metropolitan Edison Company, Pennsylvania Electric Company, Pennsylvania Power Company and West Penn Power Company (the “Companies”). The compliance filing was submitted in response to the March 6, 2014 Order of the Commission approving a Smart Meter Plan (“SMP”), but also directing certain amendments to the SMP. The June 5 Order directed that the Companies submit: 1) a corrected SMP that synchronized the page numbers of the Table of Contents with the pages of the SMP; 2) a corrected reference to the date, June 30th, on which the average annual number of meters for each customer class would be calculated, and 3) a correction to the referenced West Penn residential per kWh rate effective from July 1, 2014 through December 31, 2014.

The enclosed SMP, in redline and clean copies, implements the foregoing corrections. The correction to West Penn’s residential per kWh rate also reflects a mathematical correction explained in more detail below. In addition, the June 5 Order directed the Companies to add page numbers to portions of their final Communications Plan. A final Communications Plan is also enclosed which adds the requested page numbers.


Please note that the enclosed SMP corrects the order in which the Companies are listed in Figure 1.3 on page 13, and also makes corrections to all the Companies’ SMT-C rates for the

period July 1, 2014 through December 31, 2014 for an inadvertent mathematical error. Specifically the rates on pages 73 and 74 are corrected to eliminate an inadvertent double counting of the E factor in the calculation of the SMT-C rates.


