Energy Charge – All kilowatt-hours (kWh) – \$0.09695

TERM OF PAYMENT – A late payment charge of 2% of the net bill will be added to each bill not paid in full within 20 days from the date mailed.

LOCAL TAX ADJUSTMENT – Within municipalities or political subdivisions that impose taxes based upon the amount of electric service sold or revenues received by the company (as specified in Rule No. 18 of “Rules and Regulations for Electric Service”), there shall be added to the total bill a surcharge equal to the percentage shown on Sheet Nos. 5-1, 5-2 and 5-3 of the company’s tariff.
