# Electric Rates for West Virginia Customers

To better understand your electric charges, the approved rates as of July 15, 2025, are listed in this pamphlet. To determine your rate, refer to the Rate Schedule listed on your electric bill. If you feel another rate is more economical for you, please contact us at **800-686-0022** between 8 a.m. and 6 p.m., Monday through Friday.

W.Va. Rate Schedule B – General Service

MINIMUM BILL MONTHLY RATE – The minimum bill per month shall not be less than \$10.00 nor less than \$2.41 per kilowatt (kW) of capacity necessary to serve the customer. A kW of capacity necessary to serve under this schedule shall be defined as: (1) if a demand meter has been installed, the maximum reading of the demand meter in the previous 12 months, or, (2) the maximum number of kilowatt-hours (kWh) used in the current month, or in any of the previous 12 months, divided by 120.

TERM OF PAYMENT – A late payment charge of 2% of the net bill will be added to each bill not paid in full within 20 days from the date mailed.

MINIMUM BILL MONTHLY RATE – The minimum bill per month shall not be less than the highest of: (1) the demand charge, (2) \$2.70 per kW of the highest billing demand established during the preceding 12 months, or (3) \$2.70 times 50% of the kW capacity set forth in the agreement.
