# Electric Rates

## for West Virginia Customers

To better understand your electric charges, the approved rates as of July 15, 2025, are listed in this pamphlet. As always, our Customer Service Representatives are available at **800-686-0011** to answer your questions between 8 a.m. and 6 p.m., Monday through Friday.

### W.Va. Rate Schedule R – Residential

#### MINIMUM BILL MONTHLY RATE

(For a single residence)

Customer Charge – \$6.00 per month

Energy Charge – All kilowatt-hours (kWh) – \$0.11555

**TERM OF PAYMENT** – A late payment charge of 2% of the net bill will be added to each bill not paid in full within 20 days from the date mailed.

**LOCAL TAX ADJUSTMENT** – Within municipalities or political subdivisions that impose taxes based upon the amount of electric service sold or revenues received by the company (as specified in Rule No. 20 of “Rules and Regulations for Electric Service”), there shall be added to the total bill a surcharge equal to the percentage shown on Sheet No. 5-1 of the company’s tariff.

### W.Va. Rate Schedule OL – Outdoor Lights – restricted

#### RATE PER MONTH

- A. 9,500 lumen (100-watt) high pressure sodium lamp (51 kWh) – \$9.61 per lamp
- B. 8,150 lumen (175-watt) mercury vapor lamp (74 kWh) – \$12.19 per lamp
- C. 22,000 lumen (200-watt) high pressure sodium lamp (86 kWh) – \$14.92 per lamp
- D. 21,500 lumen (400-watt) mercury vapor lamp (162 kWh) – \$20.12 per lamp
- E. Additional facilities to provide outdoor lighting service monthly rental is \$2.02 for each standard distribution wood pole required, \$0.014 for each foot of wire for span length, and \$2.02 for each kilovar of transformer capacity installed.
