To better understand your electric charges, the approved rates as of August 1, 2026, are listed in this pamphlet. To determine your rate, refer to the Rate Schedule listed on your electric bill. If you feel another rate is more economical for you, contact us at **800-686-0011** between 8 a.m. and 6 p.m., Monday through Friday.

WV. Rate Schedule G – General Service

MINIMUM BILL MONTHLY RATE – The minimum bill per month shall not be less than \$10.00 nor less than \$2.41 per kilowatt (kW) of capacity.

Customer Charge – \$10.00 per month

First 400 kilowatt-hours (kWh)	\$0.13100 per kWh
All additional kWh	\$0.11637 per kWh

TERM OF PAYMENT – A late payment charge of 2% of the net bill will be added to each bill not paid in full within 20 days from the date mailed.

WV. Rate Schedule CSH – Church and School

NOTE – This schedule is closed except to customers transferred from Rate Schedule C-A on July 1, 2000.

Customer Charge – \$10.00 per month

MONTHLY RATE– For all kWh – \$0.10447 per kWh.

MINIMUM BILL– None.

TERM OF PAYMENT – A late payment charge of 2% of the net bill will be added to each bill not paid in full within 20 days from the date mailed.

WV. Rate Schedule E – General Service

MINIMUM BILL MONTHLY RATE – \$4.60 per kW of maximum billing demand established during the preceding 12 months. Such demand shall not be less than 50% of the kW capacity necessary to serve the customer, or less than 10 kW.

TERM OF PAYMENT – A late payment charge of 2% of the net bill will be added to each bill not paid in full within 20 days from the date mailed.

DETERMINATION OF BILLING DEMAND – The monthly billing demand will be the maximum number of kW measured over any 15-minute interval, except as modified by the provisions for off-peak service.

WV. Rate Schedule PH – Light and Power Service

MINIMUM BILL MONTHLY RATE – The minimum bill per month shall not be less than the highest of: (1) the demand charge, (2) \$2.70 per kW of the highest billing demand established during the preceding 12 months, or (3) \$2.70 times 50% of the kW capacity set forth in the agreement.
