W.Va. Rate Schedule B – General Service

MINIMUM BILL MONTHLY RATE – The minimum bill per month shall not be less than \$5.00 nor less than \$2.41 per kilowatt (kW) of capacity necessary to serve the customer. A kW of capacity necessary to serve under this schedule shall be defined as: (1) if a demand meter has been installed, the maximum reading of the demand meter in the previous 12 months, or, (2) the maximum number of kilowatt-hours (kWh) used in the current month, or in any of the previous 12 months, divided by 120.

TERM OF PAYMENT – A late payment charge of 2% of the net bill will be added to each bill not paid in full within 20 days from the date mailed.

MINIMUM BILL MONTHLY RATE – The minimum bill per month shall not be less than the highest of: (1) the demand charge, (2) \$2.70 per kW of the highest billing demand established during the preceding 12 months, or (3) \$2.70 times 50% of the kW capacity set forth in the agreement.
